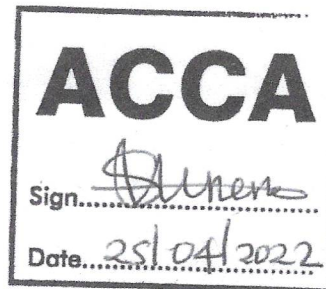

Graduation

Your award of the BSc (Hons) in Applied Accounting degree is effective from the date of the University's BSc Examination Board i.e. **21 March 2022**. You do not have to attend an Oxford Brookes Graduation Ceremony as a condition of being awarded the BSc degree but all BSc graduates will be given the opportunity to attend such an event. As a consequence of the pandemic, our usual programme of ceremonies continues to be disrupted. You will be contacted with further information on how to register for a ceremony, as soon as we are able to confirm arrangements. Until then, please do not contact us about graduations as we will not be able to provide any further information.

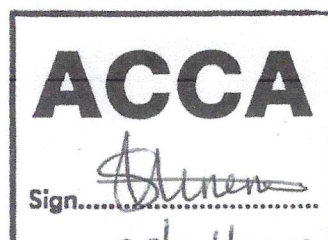
