## Interpretation of Results

These notes are provided to assist in the interpretation of the assessment results transcript provided overleaf.

### 1. Results Codes

Overall module results are displayed next to the appropriate module on the transcript. The following codes may also appear :

<b>NP</b>	Not Present, for one or more elements of assessment
<b>X</b>	Module Exemption
<b>I</b>	Module Results Deferred
<b>WH</b>	Withheld
<b>Cont</b>	Continuing Student

### 2. Progression

College regulations stipulate that students must successfully complete all modules and meet all academic requirements in order to progress to the next stage of their programme of study. Students who do not meet these requirements are required to repeat the necessary modules.

### 3. Repeat Exams

Students who repeat any number of modules in the award year of their programme of study may only receive an overall 'Pass' grade. The examination transcript will indicate the modules which must be repeated.

### 4. Pass by Compensation

Pass by compensation means that a student who has failed to attain the pass mark (40%) in a module, may, at the discretion of the Board of Examiners, pass the examined module by compensation. The pass by compensation range is 35% - 39% and the rule will only be applied if it is your first attempt at passing the module. The pass by compensation rule can not be applied where a student has been unsuccessful in one or more modules in any stage. Students should not assume that they have passed by compensation. The examination transcript will clearly indicate if the rules have been applied.

Please note that the pass by compensation rule cannot be applied to an incomplete set of results and will only be applied where possible to a full set of results as approved by the Board of Examiners in June and August.

### 5. Overall Grade

The overall grade awarded for the year is shown at the end of the examination transcript.

Where the words 'Exempt where 40% or over' appear, this indicates that the student has been unsuccessful in completing the year and is required to repeat any modules where the result is 39% or below.
